

RESOLUTION NO. 13-1140

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; ACCEPTING A REQUEST FROM WILLIAM B. WILLIFORD AND EVA E. WILLIFORD TO EXTEND THE DEADLINE FOR PAYMENT FOR PREVIOUSLY REDUCED ASSESSED CODE COMPLIANCE FINE CASE NO. C2008-0442; DIRECTING THE TOWN MANAGER TO EXECUTE ANY REQUIRED DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (“Town”), through its Code Compliance Department, issued Citation No. C2008-0442 (“Citation”) to William B. Williford and Eva E. Williford (“Previous Owners”); and

WHEREAS, on June 11, 2013 the Town Council unanimously approved a reduction request (Resolution 13-1093), reducing the total assessed fines from \$14,919.00 to \$787.21; and

WHEREAS, pursuant to Section 2 of Resolution 13-1093, the Owners were granted sixty (60) days from the date of the resolution to pay the reduced fine amount of \$787.21 subject to the owners paying the reduced penalties within sixty (60) days of the Resolution date; and

WHEREAS, the reduction expired on August 10, 2013 and the owners failed to pay the reduced penalties; and

WHEREAS, the Owner has requested that the Town grant an extension of forty five (45) days from the expiration date.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Reduction of Fine. The civil penalties/fines for the Code Compliance Case No. C2008-0442 were reduced to \$787.21 subject to the Owner paying the reduced amount no later than fourteen (14) days from the effective date of this Resolution. The Town Manager is authorized to execute appropriate documents.

Section 3. Conditions. In the event the reduced fine is not paid within fourteen (14) days of the effective date of this Resolution, the original fine amount shall be re-instated and continue to accrue interest as if this Resolution had not existed.

Section 4. Effective Date. This Resolution shall be effective immediately upon adoption.


