

RESOLUTION NO. 24-2018

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE PURCHASE OF PARK BENCHES, TRASH RECEPTACLES, AND BICYCLE RACKS, PURSUANT TO BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO UTILIZE THE UNIVERSITY OF WISCONSIN CONTRACT NO. 22-5290, PURSUANT TO CHAPTER 2, ARTICLE V, DIVISION 2, SECTION 2-157 OF THE TOWN CODE (THE TOWN'S PROCUREMENT ORDINANCE); AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the "Town") requires new benches, trash receptacles and bicycle racks at our mini parks; and

WHEREAS, Chapter 2, Article V, Division 2, Section 2-157 of the Town Code authorizes the purchase of goods and services from current contracts of other public, governmental, state/federal funded or non-profit entities, where the contracts have resulted from a formal competitive procurement process; and

WHEREAS, in 2017, the Town successfully "piggybacked" University of Wisconsin Contract No. 2017-5290, which allowed us access to for the purchase of benches, trash receptacles and bicycle racks at our mini parks, from Graber Manufacturing, Inc.; and

WHEREAS, the Town desires to continue purchasing equipment through the updated agreement between the University of Wisconsin and Graber Manufacturing, Contract No. 22-5290; and

WHEREAS, the Town of Miami Lakes (“Town”) intends to piggyback Contract No. 22-5290; and

WHEREAS, the Town Manager recommends authorization to piggyback Contract No. 22-5290 for the purchase of benches, trash receptacles and bicycle racks from the contract not to exceed budgeted funds; and

WHEREAS, the Town Council approves of the Town Manager’s recommendations and authorizes the Town Manager to initiate purchases of the Contract in amounts not to exceed budgeted funds for these goods and services.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves the piggybacking off the University of Wisconsin Contract No. 22-5290 with Graber Manufacturing, Inc., on an as-needed basis in an amount not to exceed budgeted funds.

Section 3. Authorization of Town Officials. The Town Manager and/or his designee are authorized to take all steps necessary to piggyback off the University of Wisconsin Contract No. 22-5290 with Graber Manufacturing, Inc. The Town Manager and/or his designee and the Town Attorney are authorized to take all steps, executed any and all documents, necessary to implement the terms and conditions of the University of Wisconsin Contract No. 22-5290 with Graber Manufacturing, Inc., for the purchase of Benches, Trash Receptacles and Bike Racks.

Section 4. Authorization of Fund Expenditure. Notwithstanding the limitations imposed upon the Town Manager by the Town's Procurement Ordinance, the Town Manager is authorized to expend budgeted funds to implement the terms and conditions of this Resolution on an as-needed basis.

Section 5. Execution of the Contract. The Town Manager is authorized to execute the Contract in substantially the form attached hereto as Exhibit "A" for the purchase of Benches, Trash Receptacles and Bike Racks, through the University of Wisconsin Contract No. 22-5290 with Graber Manufacturing, Inc., and to execute any required agreements and/or documents to implement the terms and conditions of the contract and to execute any extension and/or amendments to the contract, subject to approval as to form and legality by the Town Attorney.


Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.




