## **RESOLUTION NO. 25-2083**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AUTHORIZING THE TOWN MANAGER TO AWARD A CONTRACT FOR ITB 2025-08 REFUSE AND RECYCLING SERVICES FOR TOWN FACILITIES TO GREAT WASTE AND RECYCLING SERVICES, LLC, IN AN AMOUNT NOT TO EXCEED SEVENTY THREE THOUSAND, THREE HUNDRED EIGHTY SEVEN DOLLARS AND 99/100 (\$73,387.99) FOR A PERIOD OF THREE (3) YEARS WITH TWO (2) ONE-YEAR OPTIONS TO **RENEW; AND PROVIDING FOR AN EFFECTIVE DATE.** 

WHEREAS, the Town of Miami Lakes (the "Town") has determined the need for Refuse and Recycling Services for Town Facilities, including the Government Center, Royal Oaks Park, Miami Lakes Optimist Park, Miami Lakes Picnic Park West, and the Youth Center (collectively referred to as "Town Facilities"); and

WHEREAS, Chapter 2, Article V, Division 2, Section 2-155 of the Town Code provides that procurements more than \$15,000 shall require the use of competitive sealed bidding; and

WHEREAS, in accordance with Chapter 2, Article V, Division 2, Section 2-155 of the

Town Code, the Town issued Invitation to Bid ("ITB") 2025-08 for Refuse and Recycling Services for Town Facilities on February 24, 2025, with bids due on March 26, 2025; and

WHEREAS, two (2) bids were received in response to ITB 2025-08 from the following bidders: Great Waste and Recycling Services, LLC for Seventy-Three Thousand Three Hundred Eighty-Seven Thousand Dollars and 99/100 (\$73,387.99); and Evergreen Waste & Recycling Corp. for Four Hundred Nine Thousand Nine Hundred Sixty-Eight Dollars and 00/100 (\$409,968.00); and

WHEREAS, Procurement conducted a thorough due diligence review of the bids and found that Great Waste and Recycling Services, LLC ("Great Waste") submitted a responsive bid and is the lowest responsive and responsible bidder; and

WHEREAS, Great Waste has been the Town's vendor since 2019, providing Refuse and Recycling Services for all Town Facilities without issue or interruption, and has consistently demonstrated professionalism, dependability, and attention to detail in its service delivery; and

WHEREAS, Great Waste is a licensed waste hauler and recycler in the State of Florida and has provided verifiable references from clients such as the Hialeah Housing Authority, Miami-Dade County Housing & Community Development, the City of Doral, and Miami-Dade County School Board, demonstrating their capability to perform similar services; and

WHEREAS, the Town Manager recommends awarding the contract to Great Waste and Recycling Services, LLC for the amount of Seventy-Three Thousand Three Hundred Eighty-Seven Thousand Dollars and 99/100 (\$73,387.99), for a three (3) year period with two (2) oneyear options to renew, with funds budgeted for these services in the Parks – Community Services line items in the General Fund and the Facilities Maintenance Fund; and

## NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. <u>Recitals.</u> The foregoing Recitals are true and correct and incorporated herein by this reference.

<u>Section 2.</u> <u>Approval of the Contract.</u> The Town Council hereby authorizes the Town Manager to award a contract to Great Waste and Recycling Services, LLC, the lowest responsive and responsible bidder, for Refuse and Recycling Services for Town Facilities in an amount not to exceed Seventy Three Thousand Three Hundred Eighty Seven Dollars and 99/100

(\$73,387.99), for a three (3) year period, with two (2) one-year options to renew, subject to the approval of the appropriate agreements and documents.

<u>Section 3.</u> <u>Authorization of Fund Expenditure.</u> The Town Manager, his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract.

Section 4. <u>Authorization of Town Officials.</u> The Town Manager, his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract.

Section 5. Execution of the Contract. The Town Manager is hereby authorized to execute any and all necessary documents to effectuate the terms of this Resolution, including the execution of the contract with Great Waste and to execute any extension and/or amendments to the Contract, subject to approval as to form and legality by the Town Attorney.

<u>Section 6.</u> <u>Rounding.</u> As presented, the 2024-2025 Budget and Actual Expenses are rounded to the nearest hundred; therefore, line-item adjustments within \$100 are hereby incorporated within Exhibit "A."

Section 7. Effective Date. This Resolution shall take effect immediately upon adoption.
