

**RESOLUTION NO. 25-2109**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AUTHORIZING THE TOWN MANAGER TO AWARD A CONTRACT FOR ITB 2025-07, INSTALLATION OF FLOORING AT PARK FACILITIES, TO CONTRACTORS 911, LLC IN AN AMOUNT NOT TO EXCEED SIXTY-ONE THOUSAND SEVENTEEN DOLLARS AND 50/100 (\$61,017.50); AUTHORIZING A PROJECT CONTINGENCY IN AN AMOUNT NOT TO EXCEED SIX THOUSAND ONE HUNDRED ONE DOLLARS AND 00/100 (\$6,101.00); AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Miami Lakes (“Town”) issued Invitation to Bid (“ITB”) No. 2025-07 for the Installation of Flooring at Park Facilities (the “Project”) on May 5, 2025; and

**WHEREAS**, the scope of the ITB includes flooring installation at the Robert Alonso and Picnic Park East (Youth Center) Community Centers; and

**WHEREAS**, four (4) bids were received by the Town by the June 10, 2025, deadline; and

**WHEREAS**, upon evaluation and due diligence conducted by the Procurement Department, Contractors 911, LLC. (“Contractors 911”) was determined to be the lowest responsive and responsible bidder, with a proposed bid amount of Sixty-One Thousand Seventeen Dollars and 50/100 (\$61,017.50); and

**WHEREAS**, Contractors 911 met all qualifications outlined in the ITB, including requisite licensure and past performance on similar projects, and has demonstrated the ability to successfully complete the work; and

**WHEREAS**, the Town Council desires to authorize a contingency in the amount of Six Thousand One Hundred One Dollars and 00/100 (\$6,101.00), to address unforeseen circumstances associated with the Project; and

**WHEREAS**, the Town Council finds that this action is in the best interest of the Town and promotes the health, safety, and welfare of its residents.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

**Section 2. Award of Contract.** The Town Council hereby authorizes the Town Manager to award and execute a contract with Contractors 911, LLC for ITB 2025-07 Installation of Flooring at Park Facilities in an amount not to exceed Sixty-One Thousand Seventeen Dollars and 50/100 (\$61,017.50).

**Section 3. Contingency Authorization.** The Town Council further authorizes the Town Manager to approve a project contingency in an amount not to exceed Six Thousand One Hundred One Dollars and 00/100 (\$6,101.00), to be used for unforeseen conditions related to the Project.

**Section 4. Authorization of Town Manager.** The Town Manager is authorized to take all necessary steps to implement the terms and conditions of the contract and to execute any and all documents necessary to effectuate the intent of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
