

RESOLUTION NO. 25-2111

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE SELECTION OF CAMP WANNADO AFTER SCHOOL PROGRAM, INC., SNAPOLOGY OF MIAMI, AND YMCA OF SOUTH FLORIDA FOR THE AWARD OF CONTRACTS PURSUANT TO INVITATION TO NEGOTIATE (ITN) 2025-14 FOR RECREATION PROGRAM SERVICES; AUTHORIZING THE TOWN MANAGER TO NEGOTIATE AND EXECUTE CONTRACTS WITH THE SELECTED VENDORS; AUTHORIZING THE TOWN MANAGER TO NEGOTIATE AND EXECUTE CONTRACTS WITH ADDITIONAL SPECIALTY PROVIDERS, SUBJECT TO NO ADDITIONAL COST TO THE TOWN; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on May 6, 2025, the Town of Miami Lakes ("Town") issued Invitation to Negotiate ("ITN") No. 2025-14 for Recreation Program Services; and

WHEREAS, the ITN was publicly advertised via DemandStar, Public Purchase, Community Newspapers and posted in the Government Center Lobby, in accordance with Town procurement procedures; and

WHEREAS, on June 4, 2025, the Town received five (5) proposals in response to ITN 2025-14 from the following Proposers:

1. Camp Wannado After School Program, Inc.,
2. Snapology of Miami,
3. YMCA of South Florida,
4. Gym Kidz of Miami Lakes,
5. Soccer Stars & Amazing Athletes of Miami; and

WHEREAS, an Evaluation Committee was convened and conducted an evaluation meeting on June 18, 2025, during which responsive proposals were reviewed and ranked; and

WHEREAS, based on the Committee's evaluation, the top-ranked firms were as follows: YMCA of South Florida, Snapology of Miami, and Camp Wannado After School Program, Inc.; and

WHEREAS, the Evaluation Committee also recommended Gym Kidz of Miami Lakes and Soccer Stars & Amazing Athletes of Miami as additional specialty program providers; and

WHEREAS, the Town Manager recommends that the Town Council authorize negotiation and execution of contracts with the top-ranked Proposers, and, where needed and at no additional cost to the Town, enter into agreements with the additional specialty program providers; and

WHEREAS, the Town Council finds that it is in the best interest of the Town to award the contracts as outlined above to ensure continued and expanded access to high-quality recreational programming for the community.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. **Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. **Authorization of Contracts.** The Town Council hereby authorizes the Town Manager to negotiate, and upon mutual agreement, execute contracts with Camp Wannado After School Program, Inc., Snapology of Miami, and YMCA of South Florida pursuant to ITN 2025-14.

Section 3. **Supplemental Specialty Providers.** The Town Council further authorizes the Town Manager to negotiate and, upon mutual agreement, execute contracts with Gym Kidz of Miami Lakes and Soccer Stars & Amazing Athletes of Miami and/or other specialty recreation program providers, provided such contracts do not result in additional cost to the Town.

Section 4. **Term.** Any The contracts awarded pursuant to this Resolution shall be for a term of one (1) year, with options to renew annually, not to exceed a total of five (5) years.

Section 5. **Authorization of Town Manager.** The Town Manager is authorized to take all necessary steps to implement the terms of this Resolution and to execute any and all documents necessary to carry out the intent of this Resolution.


Section 6. **Effective Date.** This Resolution shall take effect immediately upon adoption.


