

RESOLUTION NO. 25-2114

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, IN SUPPORT OF SENATOR RENE GARCIA ADVOCACY AND COLLABORATION WITH CONGRESSMAN MARIO DIAZ-BALART FOR THE CREATION OF ON-RAMPS ONTO INTERSTATE 75 NORTHBOUND AND SOUTHBOUND ON NW 170 STREET BRIDGE; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR INSTRUCTIONS TO THE TOWN CLERK; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, a key strategic goal of the Town of Miami Lakes (the "Town") is the improvement of transportation network in order to ease traffic for all residents, business owners and guests alike; and

WHEREAS, the Town is privileged to have major thoroughfares of Interstate 75, State Road 826, State Road 924 and Florida Turnpike in close proximity or within the Town; and

WHEREAS, Senator Rene Garcia has been instrumental in advocating the creation of onramps onto Interstate 75 Northbound and Southbound from N.W. 170th Street, which will create access points onto Florida Turnpike, State Road 926 and 924; and

WHEREAS, a key component of Senator Rene Garcia's efforts has been in collaboration with Congressman Mario Diaz-Balart, who has been working on funding necessary studies through Congress; and

WHEREAS, it is in the Town's best interest to support Senator Rene Garcia's before the Miami Dade County Board of County Commissioners, and the collaborative efforts of Congressman Mario Diaz-Balart in furtherance of the creation of on-ramps and his advocacy on behalf of the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE
TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

Section 1. Recitals. The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Support of Senator Rene Garcia's Advocacy and Collaboration with Congressman Mario Diaz-Balart for the Creation of On-Ramps onto Interstate 75 Northbound and Southbound from N.W. 170th Street. The Town Council hereby supports Senator Rene Garcia's advocacy, and collaboration with Congressman Mario Diaz-Balart on behalf of the Town of Miami Lakes before the Miami-Dade County Board of County Commissioners for the creation of on-ramps and off-ramps onto Interstate 7f from N.W. 170th Street.

Section 3. Instructions to Town Clerk. The Town Clerk or their designee are authorized and instructed to send a copy of this resolution to Senator Rene Garcia and the Miami-Dade County Board of County Commissioners, and Congressman Mario Diaz-Balart.


Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.


