

**RESOLUTION NO. 25-2119**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AUTHORIZING THE TOWN MANAGER TO PIGGYBACK CITY OF MIAMI, FL CONTRACT NO. 1338386 (27) FURNISH AND INSTALL FENCING; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of Miami, Florida, has awarded Contract No. 1338386 (27) for the furnishing and installation of fencing, following a publicly advertised and competitively bid solicitation process; and

**WHEREAS**, the contract includes prequalified vendors offering fixed pricing for various fencing types, related products, and installation services; and

**WHEREAS**, the Town of Miami Lakes (“Town”) desires to utilize this contract to assist the Parks and Recreation Department and the Public Works Department in meeting ongoing fence installation, repair, and replacement needs; and

**WHEREAS**, piggybacking on the City of Miami’s contract will enable the Town to secure favorable pricing, expedite procurement timelines, and access reputable vendors, thereby achieving significant cost savings; and

**WHEREAS**, the contract provides access to Golden Fence Company and Loumiel General Contractors LLC, both of which are reputable and experienced vendors; and

**WHEREAS**, the Town Council finds that it is in the best interest of the Town to authorize the Town Manager to utilize the City of Miami’s Contract No. 1338386 (27) for the furnishing and installation of fencing, subject to budgeted funds and requiring future Council approval for any individual purchase exceeding Twenty-Five Thousand Dollars (\$25,000.00); and

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1.**     **Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

**Section 2.**     **Authorization.** The Town Council hereby authorizes the Town Manager to piggyback the City of Miami, Florida Contract No. 1338386 (27) – Furnish and Install Fencing – for the purchase of fencing materials, related products, and installation services from the awarded vendors under said contract, in an amount not to exceed budgeted funds.

**Section 3.**     **Council Approval Requirement.** Any individual procurement under this authorization exceeding Twenty-Five Thousand Dollars (\$25,000.00) shall require prior Town Council approval.


**Section 4.**     **Effective Date.** This Resolution shall take effect immediately upon adoption.
