RESOLUTION NO. 25-2125

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AUTHORIZING THE TOWN MANAGER TO WAIVE COMPETITIVE SOLICITATION REQUIREMENTS PURSUANT TO CHAPTER 2, ARTICLE V, DIVISION 2, SECTION 2-155(d) OF THE TOWN CODE FOR THE RENEWAL OF BUSINESS INTERNET SERVICES FOR THE MARY COLLINS COMMUNITY CENTER, ROYAL OAKS PARK, YOUTH CENTER, AND THE MIAMI LAKES OPTIMIST CLUB; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE RENEWAL AGREEMENTS WITH COMCAST BUSINESS; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes ("Town") requires reliable fiber internet services at the Mary Collins Community Center, Royal Oaks Park, Youth Center, and the Miami Lakes Optimist Club; and

WHEREAS, Comcast Business is currently the sole viable internet service provider available to the Town for these park facilities; and

WHEREAS, the Town's IT Department determined that alternatives such as AT&T direct fiber are either unavailable at this time or would require extensive construction and costs that are not financially feasible; and

WHEREAS, in accordance with Chapter 2, Article V, Division 2, Section 2-155(d) of the Town Code, the Town Council may waive competitive bidding requirements when such waiver is in the best interests of the Town; and

WHEREAS, the Town Council finds that continuing services with Comcast Business for an additional two-year term is the most cost-effective and operationally efficient option for the Town; and

WHEREAS, upon expiration of this renewal term, Town Staff will conduct market research to determine whether competitive alternatives for fiber internet service are available at that time.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. **Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Authorization of Waiver. The Town Council hereby authorizes the Town Manager to waive the competitive solicitation requirements pursuant to Chapter 2, Article V, Division 2, Section 2-155(d) of the Town Code for the renewal of business internet services for the Mary Collins Community Center, Royal Oaks Park, Youth Center, and the Miami Lakes Optimist Club.

Section 3. Approval of Renewal. The Town Council hereby authorizes the Town Manager to execute the necessary renewal agreements with Comcast Business, in substantially the form attached hereto as Exhibit "A."

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
