RESOLUTION NO. 25-2128

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AUTHORIZING THE TOWN MANAGER TO APPLY FOR AND, IF AWARDED, TO **FROM GRANT** ACCEPT **FUNDS** THE **FLORIDA** AGRICULTURE AND CONSUMER **DEPARTMENT** OF SERVICES ("FDACS") 2024 COMMUNITY FORESTRY CAPACITY GRANT, IN AN AMOUNT NOT TO EXCEED FIFTY THOUSAND DOLLARS (\$50,000); AUTHORIZING THE TOWN MANAGER TO EXECUTE ALL NECESSARY DOCUMENTS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes ("Town") is committed to enhancing, preserving, and managing its urban forest to support public safety, storm resilience, and environmental sustainability; and

WHEREAS, the Florida Department of Agriculture and Consumer Services ("FDACS") offers the Community Forestry Capacity Grant Program to assist municipalities and other entities in initiating or enhancing local urban and community forestry programs; and

WHEREAS, the Town seeks funding assistance through this program for the Miami Lakes Public Tree Inventory Project – Phase I, which will include documenting species, diameter at breast height, location, condition, potential infrastructure conflicts, and maintenance needs of all public trees within the Town; and

WHEREAS, the grant program requires a fifty percent (50%) local cost share with a maximum grant award of Fifty Thousand Dollars (\$50,000); and

WHEREAS, the estimated total cost of Phase I of the project is One Hundred Thousand Dollars (\$100,000), with the Town providing the required local match of Fifty Thousand Dollars (\$50,000) from the Tree Trust Fund; and

WHEREAS, the data obtained through this project will guide tree care, storm preparation, future canopy planning, and budgetary decisions, updating information last collected in 2014, which is now outdated and incomplete.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

- **Section** 1. **Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.
- Section 2. Authorization to Apply. The Town Council hereby authorizes the Town Manager to apply for the FDACS 2024 Community Forestry Capacity Grant in an amount not to exceed Fifty Thousand Dollars (\$50,000).
- Section 3. Authorization to Accept and Implement. If awarded, the Town Manager is authorized to accept the grant funds, execute the grant agreements, take all necessary steps to implement the terms and conditions of the agreements, and expend budgeted funds in connection with the Community Forestry Capacity Grant.
- **Section 4. Funding Source.** The required fifty percent (50%) local cost share shall be provided from the Town's Tree Trust Fund, in the amount of Fifty Thousand Dollars (\$50,000).
- **Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
