

**RESOLUTION NO. 25-2132**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AUTHORIZING THE TOWN ATTORNEY TO RETAIN THE LAW FIRM OF GRAY ROBINSON TO ASSIST WITH POSSIBLE LITIGATION; AUTHORIZING THE EXPENDITURE OF BUDGETED FUNDS; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Miami Lakes (the “Town”) previously authorized, pursuant to the memorandum approved by the Town Council at its June 17, 2025, meeting, for the Town Attorney to take affirmative steps to provide a legal framework aimed at providing legal relief to the Town and Homeowners affected by rock mine blasting; and

**WHEREAS**, the Town Attorney desires to retain the services of Leonard Collins, Esq., from the Gray Robinson law firm in order to assist with this task; and

**WHEREAS**, the Town Council finds that it is desirable and prudent for the Town Attorney to retain the services of Leonard Collins from the Gray Robinson law firm.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above-stated recitals are true and correct and are incorporated herein by this reference.

**Section 2. Authorization.** The Town Attorney is authorized to retain Leonard Collins, Esq., from the Gray Robinson law firm.

**Section 3. Expenditure of Funds.** The Town Attorney is authorized to spend up to Ten Thousand Dollars (\$10,000) of budgeted funds to retain Leonard Collins from the Gray Robinson law firm.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.


