## **RESOLUTION NO. 25-2135**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AUTHORIZING THE TOWN MANAGER TO NEGOTIATE AND, UPON MUTUAL AGREEMENT, EXECUTE CONTRACTS WITH MIAMI SOFTBALL LEAGUE CORP. FOR THE PROVISION OF ADULT ATHLETIC PROGRAM SERVICES PURSUANT TO ITN 2025-23; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AUTHORIZATION OF THE TOWN MANAGER; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes ("Town") issued Invitation to Negotiate (ITN) 2025-23, titled Adult Athletic Program Services, on August 18, 2025, which was duly advertised in the Community Newspapers, DemandStar, Public Purchase, and posted in the Government Center Lobby; and

WHEREAS, the Town received one (1) proposal, from Miami Softball League Corp. ("Miami Softball"), for the provision of adult athletic program services at the Miami Lakes Optimist Park ("MLOP"); and

WHEREAS, an Evaluation Committee, comprised of Town staff including the Director of Parks and Recreation, Parks & Athletics Manager, and Building Department Director, reviewed and evaluated the proposal on October 10, 2025, and determined that the proposal was responsive and responsible; and

**WHEREAS**, the Evaluation Committee ranked Miami Softball League Corp. as the top-ranked proposer with a total of 305 points, and recommended award based on the proposer's experience, qualifications, and demonstrated community involvement; and

WHEREAS, Miami Softball League Corp., a nonprofit organization with more than twelve (12) years of experience in adult athletic programming throughout Miami-Dade County, currently operates in the Town providing recreational softball programs for adults and residents; and

WHEREAS the Town Manager has recommended that the Town Council authorize negotiations and, upon successful agreement, the award of contracts to Miami Softball League Corp. pursuant to ITN 2025-23; and

**WHEREAS**, the Town Council finds that awarding this contract will promote recreational opportunities, community engagement, and the continued success of adult athletic programming for Town residents.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section</u> 1. <u>Recitals</u>. The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Authorization of Town Manager. The Town Council hereby authorizes the Town Manager to negotiate, and upon mutual agreement, execute a contract with Miami Softball League Corp. ("Miami Softball") for the provision of Adult Athletic Program Services pursuant to ITN 2025-23, substantially in accordance with the terms set forth in the attached Exhibit "A.".

Section 3. Authorization of Expenditures. The Town Manager is further authorized to take all necessary steps, including the expenditure of budgeted funds, to implement the terms and conditions of the contract.

Section 4. Future Agreements. Any future or long-term agreement for specialty athletic service providers outside the scope of ITN 2025-23 shall be brought to the Town Council for approval.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
