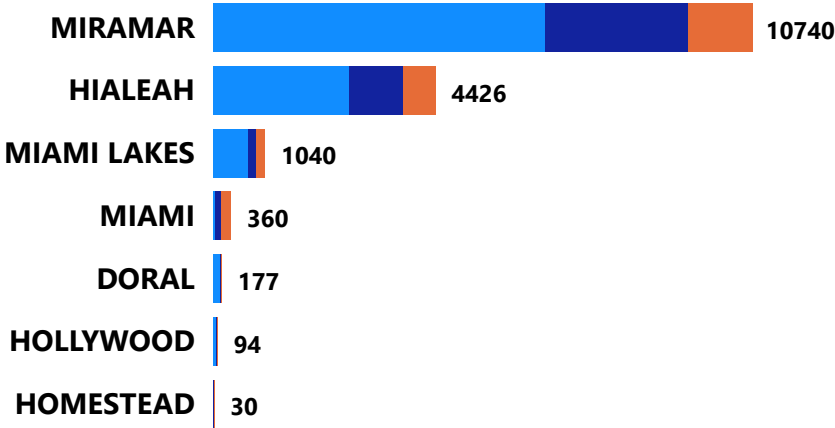

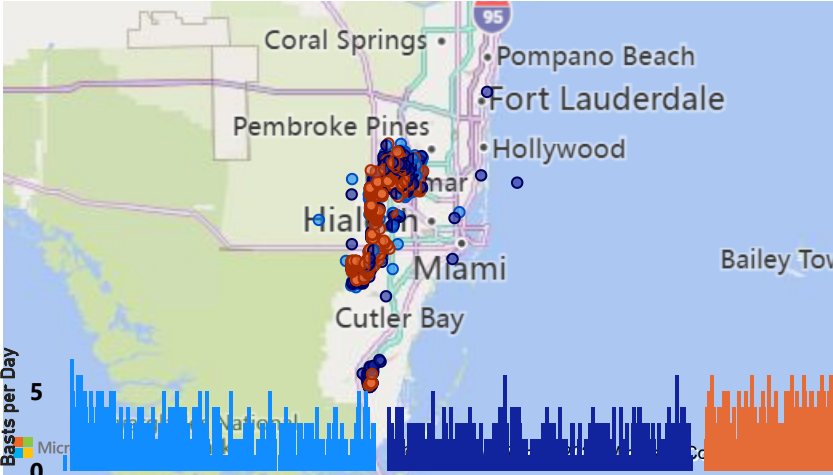

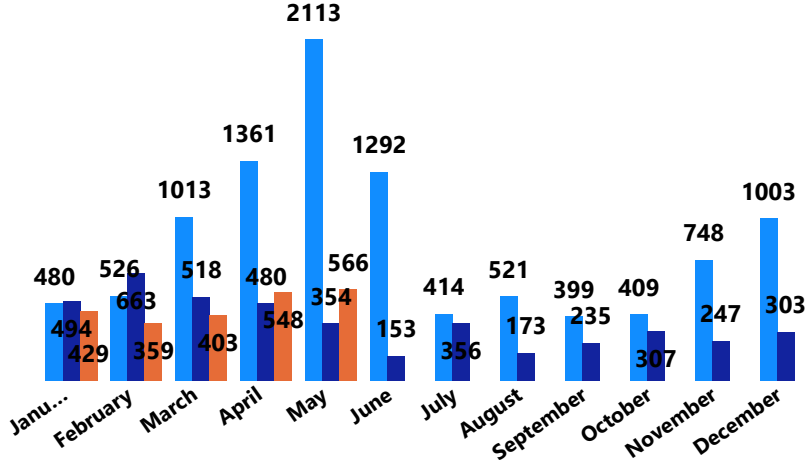
Blast Impact Locations
