

**RESOLUTION NO. 26-2153**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AUTHORIZING THE TOWN MANAGER TO ENTER INTO A CONTRACT WITH ATC ENGINEERING, INC, FOR CONSTRUCTION OF THE MONTROSE ROAD DRAINAGE IMPROVEMENT PROJECT IN AN AMOUNT NOT TO EXCEED FOUR HUNDRED FIFTY THREE THOUSAND THREE HUNDRED EIGHTY DOLLARS AND 00/100 (\$453,380.00) AND APPROVING A PROJECT CONTINGENCY OF ONE HUNDRED TWENTY EIGHT THOUSAND SIX HUNDRED FORTY NINE DOLLARS (\$128,649.00); AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Chapter 2, Article V, Division 2, Section 2-155 of the Town Code provides that procurements more than \$15,000 shall require the use of competitive sealed bidding; and

**WHEREAS**, in accordance with Chapter 2, Article V, Division 2, Section 2-155 of the Town Code, the Town of Miami Lakes (the “Town”) issued an Invitation to Bid (“ITB”) 2026-01 for the Montrose Road Drainage Improvement Project, which was advertised and solicited in accordance with the Town's procurement procedures; and

**WHEREAS**, the Town received nine (9) bids on November 10, 2025, for the Montrose Road Drainage Improvement Project, and the lowest responsive and responsible bid was submitted by ATC Engineering, Inc. (“ATC”) in the amount of Four Hundred Fifty-Three Thousand, Three Hundred Eighty Dollars and 00/100 (\$453,380.00); and

**WHEREAS**, ATC is qualified to perform the work, possesses the required experience, has provided satisfactory references, and meets the requirements set forth in the ITB; and

**WHEREAS**, the construction of the project is anticipated to be completed within one hundred sixty (160) days after the execution of the contract, and the project will be funded from the Storm Water Utility Fund; and

**WHEREAS**, the Town's Procurement team conducted due diligence and determined that Concord's bid was free of material defects and that the bid prices are fair and reasonable; and

**WHEREAS**, the Town desires to award the contract for the Montrose Road Drainage Improvement Project to ATC in an amount of Four Hundred Fifty-Three Thousand, Three Hundred Eighty Dollars and 00/100 (\$453,380.00), and provide a contingency in the amount of One Hundred Twenty Eight Thousand Six Hundred Forty Nine Dollars and 00/100 (\$128,649.00).

Furthermore, as a proactive measure to avoid any project delays, it is also recommended that the Town Council authorize the Town Manager to award the contract to the second lowest responsible bidder, National Traffic Solution, in the event that, ATC Engineering Inc. is deemed non-responsive, withdraws, or is otherwise unable to perform the work as required.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE  
TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

**Section 2. Approval of the Contract.** The Town Council hereby authorizes the Town Manager to enter into a contract with ATC Engineering, Inc., for the Montrose Road Drainage Improvements Project in the amount of Four Hundred Fifty Three Thousand, Three Hundred Eighty Dollars and 00/100 (\$453,380.00), and provide a contingency in the amount of

One Hundred Twenty Eight Thousand Six Hundred Forty Nine Dollars and 00/100 (\$128,649.00).

**Section 3. Authorization of Fund Expenditure.** The Town Manager, his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract.

**Section 4. Authorization of Town Officials.** The Town Manager, his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract.

**Section 5. Execution of the Contract.** The Town Manager is authorized to execute the Contract with ATC Engineering, Inc., and to execute any additional documents, extension and/or amendments to the Contract, subject to approval as to form and legality by the Town Attorney.


**Section 6. Effective Date.** This Resolution shall take effect immediately upon adoption.


