

**RESOLUTION NO. 26-2175**

**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, ESTABLISHING A PARKS SPONSORSHIP PROGRAM; PROVIDING FOR IMPLEMENTATION); PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town Council of the Town of Miami Lakes, Florida (the Town), desires to create a structured framework for corporate, business, organizational, and individual sponsorship opportunities to support the enhancement, maintenance, and long-term sustainability of Town park amenities, recreational assets, and commemorative improvements, while providing appropriate recognition for such contributions; and

**WHEREAS**, at prior Council meetings, the Town Council provided direction to explore opportunities for individuals and corporate partners to financially contribute to the enhancement of playgrounds and other park amenities, while being appropriately recognized for those contributions; and

**WHEREAS**, in response to such direction, the Town's Parks and Recreation Department evaluated best practices from peer municipalities, reviewed existing Town commemorative programs, and developed a structured Parks Sponsorship Program intended to expand private participation in park improvements while maintaining consistency with the Town's Code of Ordinances, aesthetic standards, and community character; and

**WHEREAS**, the Town Council finds that establishing the Parks Sponsorship Program as a formal Town initiative will provide a structured and transparent mechanism for leveraging private support to enhance the Town's park system while preserving the Town's community identity, aesthetic character, and operational oversight, and will further advance the quality of life for Town residents through innovative partnership strategies; and

**WHEREAS**, the Town Council finds that this Resolution is in the best interest of the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1.**     **Recitals Adopted.** Each of the recitals set forth above is hereby adopted, confirmed, and incorporated herein by reference as if fully set forth in this Section.

**Section 2.**     **Implementation.** The Town Manager, with the assistance of the Town Attorney are hereby authorized and directed to implement and establish the Town's Parks Sponsorship Program and take any steps to memorialize a policy, collect sponsorship dollars, and expend budgeted funds in line with the Town's Sponsorship Ordinance.


**Section 3.**     **Effective Date.** This Resolution shall take effect immediately upon its adoption.
